Framed pieces must be ready for hanging. No saw tooth or string hangers.

INSTALLATIONS RULES:

Proposals for Site Specific Installations should be submitted by the deadline and should include an artist's statement, list of materials, measurements and a sketch of the proposed installation.

ENTRY RULES:

No entry fee.

No entries smaller than 80 inches in circumference, excluding frame. (Measure the height and the width and double it).

Limit of 5 entries.

Please only one image per entry. All entries must be 300dpi in resolution, jpeg only. Please submit high quality images so that they could be used in promotions and the printed catalog.

Collectors will pay the artist directly
