Open to all artists worldwide. All entries must be original, completed in the past two years and not previously shown in the City of Redondo Beach. All mediums are welcomed.

Framed pieces must be ready for hanging. No saw tooth or string hangers.

Entry Rules

No entry fee.

No entries smaller than 60 inches total, excluding frame. (Measure the width and height and double it.)

Limit of 5 entries.

Please only one image per entry. All entries must be 300dpi in resolution, jpeg only. Please submit high quality images so that they can be used in promotions and the printed catalog.

3D should include an image of the pedestal if one is needed.

Please write the artist's first and last name on the submission. Please title each file name with the artist's first and last name and title of work, separated with an underscore.

Example: JackSmith_untitled3.jpg

Collectors will pay the artist directly.
